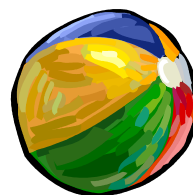
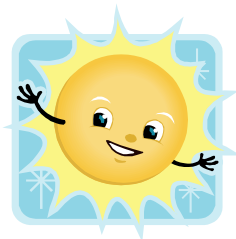
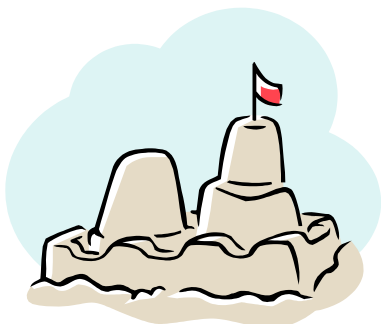

## RALEIGH WATER CUSTOMER YEAR-ROUND LAWN IRRIGATION RULES - Questions & Answers

On May 15, the Raleigh City Council approved mandatory year-round lawn irrigation water conservation measures for City of Raleigh water customers. Below are answers to the most frequently asked questions about the new rules.

Q: When do the new year-round lawn irrigation water conservation measures take effect?

A: Monday, July 2, 2007

Q: Who will be impacted by the new mandatory rules?

A: The new measures will apply to all City of Raleigh water customers, including those in nearby towns that have merged their water and sewer systems with Raleigh and now receive water from the Capital City. Those towns are Garner, Rolesville, Wake Forest, Knightdale, Wendell and Zebulon.

Q: Which lawn irrigation systems are covered by the new year-round lawn irrigation water conservation rules?

A: Specifically, the regulations will apply to the use of automatic and non-automatic irrigation systems and hose-attached sprinklers. Beginning July 2, Raleigh water customers will be allowed to use these types of lawn irrigation systems only three days a week to water lawns and outdoor plants. Raleigh water customers who have odd-numbered addresses can water anytime of day on Tuesday, Thursday and Saturday. Even-numbered addresses can water anytime of day on Wednesday, Friday and Sunday. Lawn watering by automatic or non-automatic irrigation systems or hose-attached sprinklers is **not** allowed at all on Monday.

Q: What if I use a hand-held water hose to irrigate my lawn and outdoor plants?

A: City of Raleigh water customers who use hand-held hoses will be exempt from the mandatory year-round rules and can water lawns and outdoor plants at anytime, but must be holding the hose.

Q: What are the penalties for violating the year-round lawn irrigation water conservation rules?

A: A written notice will be issued for a first violation of the mandatory measures once observed by Raleigh Public Utilities staff. A second violation will be a \$50 fine, and a third violation will result in a \$200 civil penalty. A fourth violation will be interruption of the customer's water service till compliance with these requirements is assured.

Q: Why is the City of Raleigh implementing these mandatory year-round lawn irrigation rules?

A: The new rules were among the recommendations made by the City's Water Conservation Task Force in a comprehensive report to the City Council in the summer of 2006. New water supply sources are very expensive and very difficult to develop. The City is implementing the new water conservation rules to extend the capacity of the City's current and future water supply sources, especially in times of severe drought. Several North Carolina municipalities already have similar lawn irrigation restrictions, including Cary, Greensboro and Fayetteville.

Q: In addition to complying with the new mandatory year-round lawn irrigation water conservation rules that go into effect on July 2, what can City of Raleigh water customers do voluntarily to help conserve water?

#### **Sec. 8-2175. MANDATORY WATER USE RESTRICTIONS.**

It *shall* be unlawful for any *person* to use water from the *public water supply system* of the *City* in violations of the following mandatory water *conservation* restrictions:

- (a) All Stage 1 mandatory conservation restrictions and rules as set forth by any ordinance adopted by the City Council.
- (b) All Stage 2 mandatory conservation restrictions and rules as set forth by any ordinance adopted by the City Council.
- (c) Every day mandatory water conservation restrictions
  - (1) To use water from City of Raleigh *public water supply* for *automatic and non-automatic irrigation systems* and for *hose end sprinklers* except:
    - a. *Properties* with **ODD** numbered addresses *may* water lawns and landscapes only on **TUESDAY, THURSDAY and SATURDAY**.
    - b. *Properties* with **EVEN** numbered addresses *may* water lawns and landscapes only on **WEDNESDAY, FRIDAY and SUNDAY**.

*No automatic or non-automatic irrigation systems or hose end sprinklers shall be operated on **MONDAY**.*

*Notwithstanding the limitations of subsections a and b above, City certified automatic irrigation system installations approved pursuant to section 8-2169 may be operated on the days and at times determined by the system controller sensors for weather, soil and other conditions in order to maximize the efficiency of water use and minimize the consumption of water or as necessary for testing and calibration of the system controller. But no certified automatic irrigation system approved by the City may operate during a Stage 1 water conservation restriction period except in conformity with applicable Stage 1 requirements. A placard issued by the City's Public Utilities Department shall be displayed on the street yard of the property.*

- (2) Violations of Section 8-2175(c) *may* be punished by any of the means available to the City pursuant to N.C.G.S. 160A-175. A written warning will be issued for the first violation of 8-2175(c). A civil penalty of \$50.00 *shall* be assessed for the second violation of Section 8-2175(c) and a third violation *shall* result

in a civil penalty of \$200.00. A fourth violation will result in interruption of water service to the offending customer. The City will issue written notification to the customer and occupant of intent to interrupt water service and twenty-four (24) hours later will interrupt water service. If water service has been interrupted due to repeat violation of Section 8-2175(c), service will not be re-instated until the Public Utilities Director has determined that the risk to the City water supply has been alleviated or the Public Utilities Director is otherwise assured of compliance.
